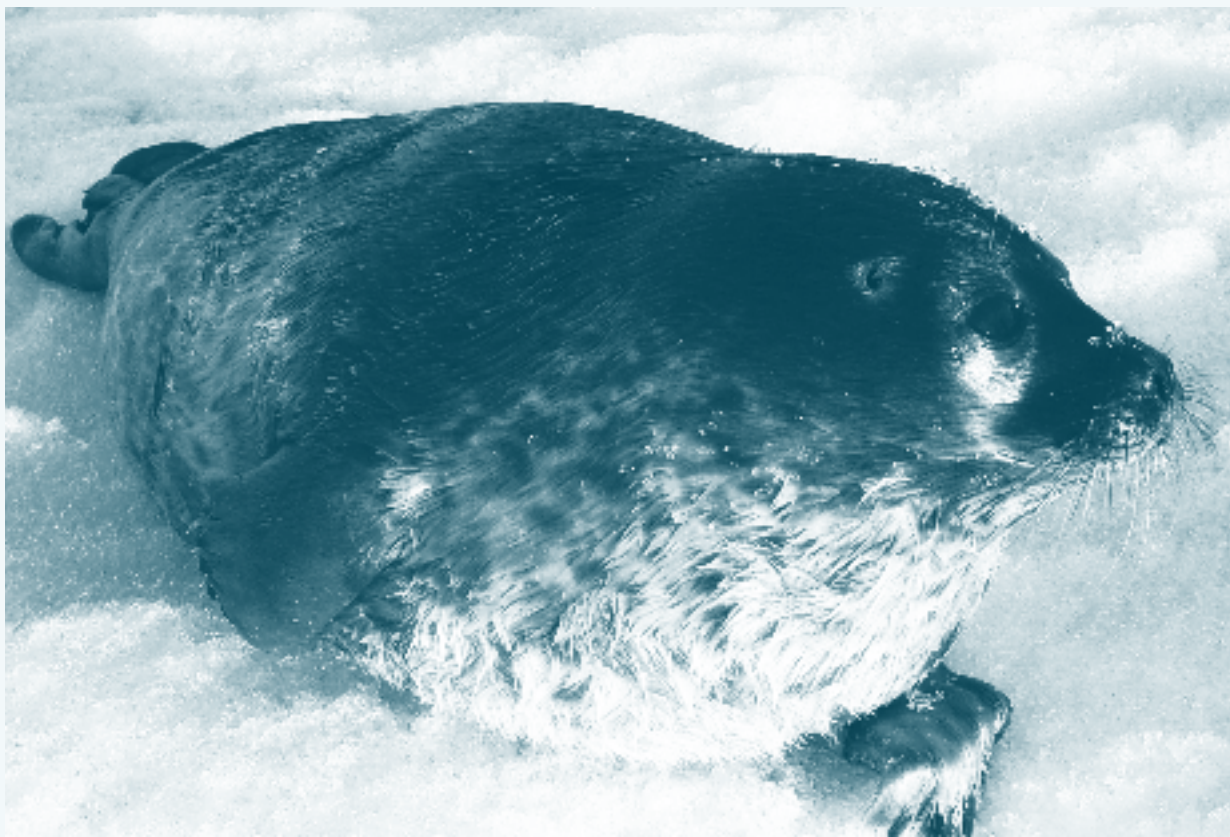

Hamna Katimayit huli havakhimmaartangit kiudjuhiinit tuhaumayakhait ihumaliurutikhainillu haffumingat amiriyangit parnauqatigiiktunut atuqattartangit umayunit tamainnut Nunavunmi Nunatarviup Iluani. Hapkuat katimayut, tuhaumayakhait unalu ahiit huliyakhait turaartitayut uvani ukiungani aturtumi tukiqaqhutik ataaniittut.

Uvani Desaipa 24, 2010 mi, ilitturiyauvlunga tikkuartaavlunga Ikhivautakhamut ukuningat NWMB pilihaartumi angiqatagiikhutik haffumingat Kavamatuqatkunni Ministauqatigiit Katimayit. Hivumuurumayatka inirtiqlimalugit hivunikhautingit havaariyakhautingit hamna kinguani iniritutikhatka.

Hamna Katimayit havaanikhannikhuni malrurnik nutaamik Amirinahuartakhanut Avatiliriyiunut inikhautikhait, Rebecca Jeppesen unalu Lesley Farrow, taimaa havalluariyukhauningit havaamingnit. Una Katimayit quyayumayangit havaktiita havagluaraktangit hapumminahuarpagangit uvani havagluartamingnit ukiungani. Hamna Katimayit iniqhimayangit ukiungani una atauhiq Avatiliriyi inikhautingit inuittumik uvani ukiumi kinguani.

Una Katimayit 5 nit Katimaqattautihimayangit, 8 nit Hivayautigut Katimavakhutik, 10 nit inikkut Katimayut, 12 nit Iluani Inmikkut-Katimayut uumingalu 5 nit Tuhartittinahuartangit Tuhaumayakhait haffumingat hivuniginahuartangit titiraqhimayut uumingat nanuup uumayunut haffumingat naunaiqhittaartut ihumaalutingit malikhimayangit kavamatuqainit Nalunaiqhittaarnikkut Hapimmukhautiyukhat Atuqaq, hamna uukturautingit tamainnut ilauqataunikkut angunahuartunut haffumingat Davis Strait nanuit amihuuningit, hamna hivunikhaliurtut titiqqait haffumingat Kivataani Ukiuqtaqumiuttat-Qikiqtaalungmi qilalugait amihuuningit uumayunit ihumaalutavlutik ataagut kavamatuqangit Umayunit Hapummiyauyukhat Atuqaq. Uvani ilaliutayunit, NWMB havaktiita katimaqataavlutik hamna pingahut Aviktuqhimayumi Umayuliriyiit ukiungani katimayuartunut ahiittauq amihunit aulattiqataayunut qauyihainikkullu katimayut haffuminga aalatqiit umayunit mikhaagut.

Aivaqattautiyut katimataaramik ukuningat NWMB't aulattiqatigiiktut parnautigiiktut kinguani Juun 2010 mi, tugliata angunahuarnikkut qauyihaiyunut himmautauniaqhutik uumingat Nunaqagiikmiuttanut-Amiriyauyukhat Katimaqatigiiktut (CBMN) Uukturautingit Qauyihaiyut. Naittumik kiuhimayut, una CBMN pinahuarumayut aktuqhimmaarlutik iniqhimayumik angunahuartunut naunaiyailutik umayunit ihivgiurtamingnit kititirlutigli nalunaitkutaanit uvani tigummilaartumik qaritayamuurlugit ingulrutainit, aturtakhainit haffumingat NWMB, uumingat aulattiqatigiiktut, unalu nunqatigiikmiuttat inmikkut uvani aalatqiit umayulirinnikkut aturtakhainit. Hamna pigiaqhimayangit qauyihainikkut, inikhautingit unalu ukpiruhuutainit ukuningat qauyihainahuarnikkut pivalliahimayut. hamna nutaaq hivunikhautikhangit ikayuutauniaqhuni hamna CBMN Uukturautingit Qauyihaiyut hivumuuhuni aippaagut havaariyakhap ukiumi.

Una NWMB huli akturtaunahuaraaqhutik haffumingat ukiungani havaariyakhami havakhimmaarlutik hivunikhautimut hivunikhaliurahuarlutik haffumingat Avguinikhautit Atuqaq haffumingat piyumayainnit tamainnut Nunavunmiunut.

Una Nunavut Umayuliriryuanga Qauyihainikkut Tutquumayut (NWR) aulattitiyut ukuningat adjigiiktumik NWMB Katimayit kinali, tikkuaqhimayut, nanminiriyavlutik "Tutquumaliyuvlutik". Uumingattauq naunartumik hilaryuap maniliurahuarningit, una Nunavut Umayuliriryuanga Qauyihainikkut Tutquumayut huli ihumannartunik angiklivallialiqhutik uukturautainnit angiyartumik ilautainit haffumingat Maniliurtangit Ukuttuyunit Ihuaqhirariiqhimayut Maniliritigut. Una NWMB uvani ukiungani havaariyakhautainit iniqhimayangit hivunikhautiyakhainit uumingat Nunavut Umayuliriryuanga Qauyihainikkut Tutquumayut unalu Nunavut Umayuliriryuanga Qauyihainikkut Maniktautikhainit (NWSF) atuqait, ilaliutavlutik pilihaartumik haffumingat maniliurnikkut maliktakhait ikayurhimmaaqhutik aturumayunit aturtakhainit.

Una NWMB huli angiqhimayangillu \$129,125 haffumingat NWSF ukuningat tallimat nunalingnit-qauyihaiyakhautit havaariyakhait ukuningat nunaqatigiikmiuttat HTOT, RWOT unalu ahiit nunaqatigiikmiuttat gavamaunngittut katudjiqatigiit uuktumalaaqhutik.

Amihuuningit aturuminaqtukhat uvani 2010-2011 ukiumi haffumingat uukturautikhamut/uuktuffaarumiyukhanut haffumingat hitamauyut Atuqaq Maligautikhait ukuningat Kavamatuqatkunni, Havaktuliyiyiit uumingattauq Maniliqinikkut Aulattitiniq. Una Katimayit iniqhimayangit angiqhimayangillu uumingat Umayuliriyiit

Maliktakhait unalu Maniliqinikkut Maliktakhait ilaliutauvlutik amihuuyut atuagait unalu uukturautikhait.

Una NWMB huli aturaarpaktut ukuningat havaktamingnit hivunigivlutik ukuningat ilaliutigivlutik uumingat Inuit Qaujijamajutqangit (IQ) uumingat umayulirinikkut aulattitinikkut unalu iluani Katimayit ublunganiit aulattitiyunit. Una Katimayit pilihaarhutik pivalliavlutiklu havaariyakhait NWMB IQ piliriakhat uumingat pinahuarhutik aulaqtitiyunut pilimmakhainik inikhangit uvani aturtakhami ukiukkut havaariyakhait.

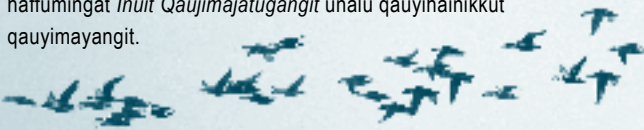

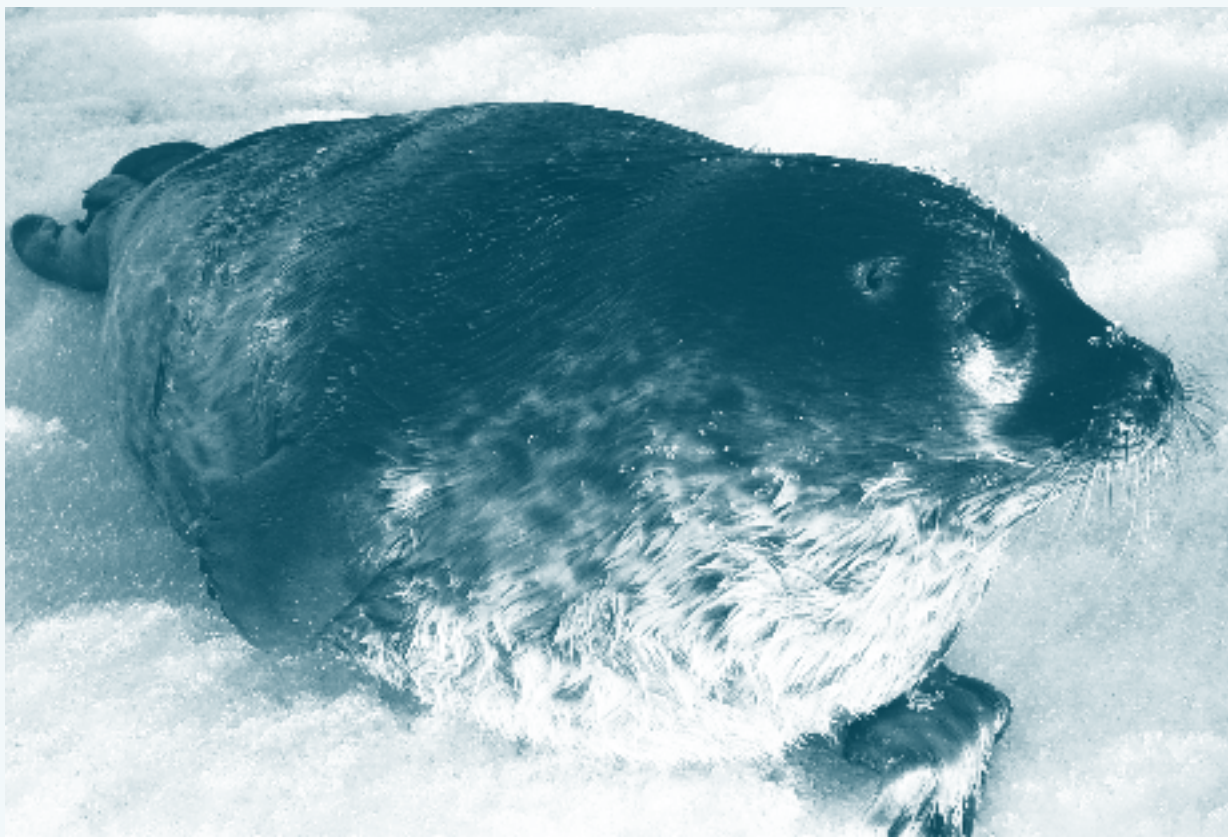

Message from the Chairperson

The Board continued to be highly active with requests for hearings and decisions from co-management partners and users of wildlife throughout the Nunavut Settlement Area. The meetings, hearings and other activities that were carried out during the course of the past fiscal year are outlined below.

On December 24th, 2010 I was formally appointed as Chairperson to the NWMB based on approval from the Governor in Council. I look forward to assisting the NWMB in achieving its goals and objectives until the end of my appointment.

During this fiscal year, the Board bid farewell to Robert Kidd, Director of Wildlife during March 2011. The Board had also hired two new Management Biologist positions, Rebecca Jeppesen and Lesley Farrow, so it could become more proactive in its work. The Board would like to thank its staff for their dedication and perseverance during a very busy past year. The Board ended the year with one Biologist position vacant at year-end.

The Board held 5 Regular Meetings, 8 Conference Call Meetings, 10 In-Camera Meetings, 12 Internal In-Camera Meetings as well as 5 Public Hearings regarding the proposed listing of polar bear as a species of special concern under the federal Species at Risk Act, the level of total allowable harvest for the Davis Strait polar bear subpopulation, the proposed listing of Cumberland Sound beluga as a threatened species under the federal Species at Risk Act and the proposed listing of the Eastern High Arctic-Baffin Bay beluga population as a species of special concern under the federal Species at Risk Act. In addition, NWMB staff attended the three Regional Wildlife Organizations' annual general meetings as well as various co-management and scientific meetings regarding various species.

After discussion with the NWMB's co-management partners in late June 2010, the second harvest study will be replaced with a Community-based Monitoring Network (CBMN) Pilot Study. Briefly stated, the CBMN intends to rely upon accomplished harvesters to record wildlife observations and catch data onto hand-held electronic devices, for use by the NWMB, its co-managers, and the communities themselves in various wildlife management applications. The background research, approach and methodology for the study were developed. The project will begin with a pilot study in three Nunavut communities, with data collection slated to begin in fall 2011. The hard work achieved during this fiscal year towards this new focus will be beneficial as the CBMN Pilot Study moves forward during the next fiscal year.

The NWMB received and considered recommendations from the Fisheries Advisory Committee on both turbot and shrimp allocations for 2011 and made a number of allocation decisions for the Nunavut Settlement Area. In addition, the NWMB initiated a comprehensive review of its "Allocation Policy for Commercial Marine Fisheries" including a workshop held with industry and co-management partners in October 2010. The NWMB will continue to build on this achievement from this fiscal year and work towards a final revision of the Allocation Policy for the interest of all Nunavummiut.

The Nunavut Wildlife Research Trust (NWRT) is operated by the same NWMB Board Members who, upon appointment, are automatically "Trustees." Despite the uncertainty in world markets, the Nunavut Wildlife Research Trust maintained a respectable growth rate due to a major portion of the Asset Mix being in Fixed Income. The NWMB during this fiscal year also completed major revisions to its Nunavut Wildlife Research Trust and Nunavut Wildlife Studies Fund (NWSF) policies, including the creation of funding guides to assist potential applicants.

The board allocated \$757,070 of NWRT funding towards government departments' wildlife research projects for the 2010-2011 year. In total, the Board approved 17 single-year research projects and the final year of several multi-year research projects.


The NWMB also approved \$129,125 from the NWSF for five community-based research projects for which local HTOs, RWOs and other local non-government organizations are eligible.

Further progress was made during the 2010-2011 year on the drafting/redrafting of four Policy Manuals for Governance, Human Resources as well as Finance and Administration. The Board completed and approved its Wildlife Manual and Finance Manual including a number of policies and procedures.

The NWMB continued to build upon its work pertaining to the inclusion of Inuit Qaujijajatuqangit (IQ) in wildlife management and in the Board's day to day operations. The Board initiated and developed a proposed NWMB IQ program in which it intends to start the implementation stages in the next fiscal year.

When the Nunavut Wildlife Management Board's 2010/2011 Annual Report is published, it will be distributed to all the wildlife partners including: the community Hunters' and Trappers' Organizations, Regional Wildlife Organizations, Nunavut Tunngavik Incorporated, Federal and Territorial governments as well as the Department of Indian Affairs and Northern Development. This report will also be distributed to all Nunavut schools and community libraries. The NWMB's annual report is published in English, Inuktitut and Innuinaqtun languages. The section of the annual report covering "NWMB Implementation Activities" provides the reader with extensive details of the activities and progress. Many of the activities are "works in progress." The report also contains audited financial statements for both the Nunavut Wildlife Management Board and the Nunavut Wildlife Research Trust including the listing of individual Research Projects.

NWMB Implementation Activities

During the 12 months from April 1st 2010 to March 31st 2011, the NWMB continued to perform its core functions in a thorough and timely fashion, and to ensure the continued maintenance of a model wildlife management system that has the confidence of the public, Inuit and Government. Set out in this section is a description of the NWMB implementation activities undertaken during the 2010-2011 period. Below each general activity, written in blue, is a progress report of specific results and achievements.

- Continue to design, and work towards the implementation of, the second Nunavut Wildlife Harvest Study (HS2);
 - Establishment of an NWMB Harvest Study Review Committee (May 10, 2010); Development and approval of an *HS2 Action Plan for June to September 2010* (June 2010)
 - HS2 planning meeting with co-management partners (June 30, 2010) where the concept of a Community-based Monitoring Network (CBMN) was put forward;
 - Communications held with NTI, the Nunavut Inuit Wildlife Secretariat, the Canadian Circumpolar Institute, and others with expertise in Harvest Studies, on the design of a CBMN (June to October 2010);
 - Contracted with experts and co-management partners for advice concerning study parameters to be specified in a *request for Proposals*;
 - *Request for Proposals* for CBMN pilot study design and implementation released (December 2010);
 - Proposals received, reviewed by staff and the Harvest Study Review Committee (January 2011);
 - References of the company submitting the top ranking proposal contacted (February 2011);

- The NWMB Harvest Study Review Committee entered discussions with the top ranking proponent to discuss a way forward (February 2011);
 - Amended methodology to the proposed study design was received from the proponent and was reviewed by NWMB staff and the Harvest Study Review Committee (March 2011).
- b) Continue the introduction of the *Total Allowable Harvest-Basic Needs Level-Surplus* (TAH-BNL-Surplus) management regime for particular stocks or populations of species in the NSA;
- The NWMB committed to establishing Total Allowable Harvests (TAHs) for narwhal, beluga and walrus with the federal Fisheries and Oceans Minister and consulted with its co-management partners on the approach;
 - Staff continues to discuss with its co-management partners the approach to establishing Basic Needs Level (BNL) for narwhal, beluga and walrus;
 - The NWMB committed to participating in the Department of Fisheries and Oceans' community consultations on narwhal TAH science advice.
- c) Pursuant to the principles of conservation, and in conformity with the development and initial introduction of the TAH-BNL-Surplus management regime, make appropriate decisions with respect to maintaining, establishing, modifying or removing TAHs and other restrictions on wildlife harvesting in the NSA;
- TAH and Non-Quota Limitation (NQL) (e.g. season and boundary changes) modifications were made for muskoxen in the Kivalliq and East Kitikmeot Regions of Nunavut (April 2010);
 - The TAH for the Western Hudson Bay polar bear subpopulation was increased by 6 bears for the 2010-2011 harvest season;
 - Engaged in the decision making process as per Section 5.3.21 of the NLCA to establish a TAH and BNL for the Kingnait Fiord arctic char fishery;
 - A number of NQL decisions have been made pertaining to commercial fisheries within the Nunavut Settlement Area (e.g. gear changes in hook size, identification of by-catch protocols, and vessel monitoring systems);
 - Approved a number of requests for the carryover and borrowing against of quota for narwhal as per the narwhal flexible quota system (i.e. Taloyoak, Kugluktuk, Grise Fiord).
- d) Conduct Public Hearings, as necessary, into issues of high public importance that require NWMB decisions;
- Public hearings were held on the proposed listing of polar bear as a species of special concern (April 13th-15th, 2010) and Cumberland Sound beluga population as a threatened species (June 22nd-23rd, 2010) under the federal *Species at Risk Act*;
 - Written hearings were conducted on the proposed listing of the Eastern High Arctic-Baffin Bay beluga population as a species of special concern (March 19th-May 14th, 2010) and Western population of horned grebe as a species of special concern (June 30th-August 20th, 2010) under the federal *Species at Risk Act*.
- e) Continue to equitably allocate Nunavut's share of commercial shrimp, turbot, and other marine resources among eligible fishers through implementation of the *Allocation Policy of the Nunavut Wildlife Management Board for Commercial Marine Fisheries*;
- Allocated 1000mt from Shrimp Fishing Area 2 to the Baffin Fisheries Coalition for the 2010 fishing season to test shrimping vessel and gear;
 - The NWMB issued a public call for 2011 commercial fisheries allocation applications;
 - The NWMB corresponded with relevant co-management partners and the Nunavut fishing industry regarding the 2011 allocations;
 - The NWMB made all of its commercial marine fisheries allocation recommendations and decisions for 2011 pursuant to the *Allocation Policy of the Nunavut Wildlife Management Board for Commercial Marine Fisheries*;
 - The NWMB initiated the process of revising and updating the *Allocation Policy of the Nunavut Wildlife Management Board for Commercial Marine Fisheries* through a fall workshop (October 18th-19th) and continued consultations with the Nunavut Fishing Industry and Co-management partners;
 - The NWMB issued a public call for applications for 1000mt of northern shrimp in SFA 2 E of 63°W;
 - The NWMB consulted with the Fisheries Advisory Committee regarding their recommendation for allocation of the above shrimp quota.
- f) In cooperation with the NWMB's relevant co-management partners, continue the development of a Nunavut Fisheries Licensing Policy;
- On April 21st 2010, the NWMB delivered a presentation ("*Fisheries Challenges, Fisheries Opportunities*") to the Nunavut Fisheries Symposium, which included a discussion of the need for a Nunavut Fisheries Licensing Policy;

- The NWMB met in-person with DFO, NTI and the GN to discuss, among other fisheries matters, the development of the Licensing Policy (May 2010);
 - A two-day marine fisheries allocation policy review workshop was held October 19th and 20th with industry, and co-management partners, at which the Nunavut licensing policy was discussed;
 - The NWMB met with Fisheries and Oceans Canada Regional Director General to discuss the Nunavut Fishery Regulations, Nunavut Fisheries Licensing Policy, and other legislation (September 17th, 2010).
- g) Based upon the Board's 2009-2010 review, analysis and recommendations concerning the Community-Based Management (CBM) system for narwhal and beluga whales, and in cooperation with the NWMB's relevant co-management partners, work towards making further improvements to the conservation and shared, pro-active management of narwhal and beluga whales in Nunavut;
- NWMB has initiated the process to establish TAH for narwhal and beluga as per its decision to discontinue the trial Community Based Management (CBM) programs in which the Board made a commitment to moving towards the implementation of the *Nunavut Land Claims Agreement* through the establishment of TAHs and BNLs for these marine mammals;
 - In initiating the process for the establishment of TAH and BNL for narwhal and beluga, the NWMB: (1) requested and reviewed TAH recommendations for narwhal and beluga from DFO; (2) requested and reviewed further information pertaining to the proposed summering stock approach to managing narwhal and beluga; (3) held meetings with DFO and NTI to discuss how to proceed with the establishment of TAHs and BNLs for narwhal and beluga;
 - Worked with its co-management partners to develop a policy on the flexible quota system (former component of the CBM program) for narwhal.
- h) Continue to promote the inclusion of both IQ and modern science in all aspects of wildlife management;
- The Community-based Monitoring Network (CBMN) will record and quantify local ecological knowledge through harvester-led data collection of wildlife observations. The information will be applicable to all co-management partners in wildlife management;
 - The NWMB presented a Submission to the Standing Committee on Environment and Sustainable Development concerning the Species at Risk Act, which specifically addressed concerns pertaining to the inadequate attention of Aboriginal Traditional Knowledge (ATK) in the Species at Risk Act (SARA) and recommended to the Committee that an ATK Institute be established and that the language of SARA concerning ATK in management and recovery measures be improved (May 6, 2010);
- NWMB staff met with university and government researchers to provide advice on scientific and IQ research being conducted in Nunavut;
 - NWMB staff has sent a request to co-management partners for a meeting to discuss the NWMB's proposed IQ program that was developed after review of a consultant's report on how to use IQ in wildlife management.
- i) Make appropriate decisions with respect to the approval of plans for the management and/or protection of particular wildlife or wildlife habitats;
- The NWMB has been engaged in the review of the National Polar Bear Conservation Strategy and National Bird Conservation Regional Plans;
 - The NWMB approved the federal Auyittuq National Park Management Plan;
 - The NWMB approved the Management Plan for musk-oxen in the Kivalliq Region;
 - The NWMB continues to discuss with its Co-management partners and the Nunavut shrimp fishing industry proposals to amend existing shrimp fishing areas within the Nunavut Settlement Area to improve the fishery management and conservation of striped shrimp stocks.
- j) Continue to provide guidance and advice on wildlife management and research proposals and priorities;
- NWMB held Regional Wildlife Management and Research Priority Workshops to identify regional priorities pertaining to wildlife management and research (Kitikmeot September 18-19; Kivalliq October 2-3, Qikiqtani November 20-21, 2010);
 - NWMB completed the review and revision of its Nunavut Wildlife Research Trust, Nunavut Wildlife Studies Fund and Identification of NWMB and Regional Wildlife Management and Research Priorities for Nunavut policies;
 - NWMB staff met with university and government researchers to provide advice on scientific and IQ research being conducted in Nunavut;
 - NWMB reviewed and provided support for the Northern Shrimp Research Foundation (NSRF) and Fisheries and Oceans Canada research survey.

- k) Continue to evaluate Government and non-government Research Funding Proposals, and to provide funding to researchers from the *Nunavut Wildlife Research Trust (NWRT)* and the *NWMB Studies Fund (NWSF)*;
- NWMB ensured that 2009-2010 applicants submitted the required Final Reports as per the funding conditions for the NWRT and NWSF;
 - NWMB reviewed 35 applications for funding for the 2010-2011 funding period for the Nunavut Wildlife Research Trust;
 - NWMB approved 17 applications for funding for the 2010-2011 funding period for the Nunavut -Wildlife Research Trust totaling \$757,070;
 - NWMB reviewed 8 applications for funding for the 2010-2011 funding period for the Nunavut Wildlife Studies Fund;
 - NWMB approved 5 applications for funding for the 2010-2011 funding period for the Nunavut Wildlife Studies Fund totaling \$129,125;
 - NWMB ensured that funding conditions for successful applications for the 2010-2011 funding period for the NWRT and NWSF were met prior to the finalization of Contribution Agreements;
 - NWMB reviewed 17 interim progress and financial reports from the 2010-2011 funding period for the Nunavut Wildlife Research Trust;
 - NWMB reviewed 5 interim progress and financial reports from the 2010-2011 funding period for the Nunavut Wildlife Studies Fund;
 - NWMB sent a request for applications for the NWRT and NWSF to Government Departments, Regional Wildlife Organizations (RWOs) and Hunters and Trappers Organizations (HTOs) for the 2011-2012 funding period.
- l) Continue to ensure that wildlife research data and results from projects funded by the NWMB are made available to the public – particularly through the Nunavut Wildlife Resources Coalition Centre (NWRCC) libraries – and encourage others to do likewise;
- NWMB filed Final Reports from the NWRT and NWSF in the NWRCC library system;
 - The NWRCC website is maintained on a consistent basis;
 - NWMB conducted the NWRCC annual meeting.
- m) Continue to attend consultations between Canada and Greenland on shared wildlife stocks, and continue to work with administrative agencies and aboriginal peoples from other land claims areas concerning shared wildlife stocks;
- NWMB staff attended and participated in a number of meetings and conference calls with the Advisory Committee on the Cooperation of Wildlife Management (ACCWM) to continue work on inter-jurisdictional wildlife matters between Nunavut, the Northwest Territories and the Yukon;
 - NWMB participated in interjurisdictional meetings concerning the Davis Strait polar bear subpopulation.
- n) Continue to provide funding to the RWOs and HTOs through the Nunavut Inuit Wildlife Secretariat (NIWS);
- The NWMB has continued to provide timely quarterly payments during the first part of the current fiscal year. Payments from the NWMB are provided to the Nunavut Inuit Wildlife Secretariat (NIWS) in trust for the RWO's and HTO's.
- o) Continue to communicate and work in cooperation with HTOs, RWOs, the NIWS, NTI and Government Departments, and with other institutions of public government (IPGs) concerning land and resource management issues affecting Nunavut;
- NWMB participated in RWO AGM's of all three regions of Nunavut;
 - Conference call held with DFO (August 24) regarding future collaboration on conservation education initiatives;
 - User to user Inter-jurisdictional meeting on Davis Strait Polar Bear was held September 14-16 with Inuit representing Nunavut, Nunavik and Nunatsiavut;
 - NWB, NIRB, NPC and the NWMB agreed on a Nunavut Marine Council (NMC) Memorandum of Understanding (MOU) to formally establish the NMC.
- p) Work towards completing the NLCA decision-making processes for draft harvesting limitations in the Wildlife Regulations and Orders proposed by the GN under *Nunavut's new Wildlife Act*;
- As it has done on a consistent basis each year since delivering its June 2008 *Decision Report to the Minister of Environment concerning harvesting limitations in the 2008 Nunavut Wildlife Regulations and Orders*, the NWMB continues to urge the GN – through phone and written communications (May 13/10 and June 17/10) – to re-engage with the NWMB in this NLCA decision-making process.
- q) Continue to implement the DFO – Environment Canada – NWMB *Memorandum of Understanding to Harmonize the Designation of Rare Threatened and Endangered Species under the Nunavut Land Claims Agreement and the listing of Wildlife Species at Risk under the Species at Risk Act (MOU)*;

- NWMB completed the MOU process for: peregrine falcon, red knot (*islandica*), red knot (*rufa*), short-eared owl and Eastern High Arctic-Baffin Bay beluga;
 - Currently the MOU process is underway for: polar bear, Cumberland Sound beluga, horned grebe (western population), and Atlantic cod (Arctic Lakes population);
 - NWMB made a submission and recommendations to the Standing Committee on Environment and Sustainable Development concerning the parliamentary review of the *Species at Risk Act* (April 30th, 2010).
- r) Continue to work closely with Government and Inuit in ensuring that new and amended legislation affecting Nunavut recognizes and respects land claims agreements and the jurisdictions of land claims bodies (e.g. progress in development of the *Nunavut Fishery Regulations*, as well as Regulations and Orders required pursuant to the territorial *Wildlife Act*); and
- The NWMB wrote to the DFO Minister with a proposal to re-start the stalled development of the *Nunavut Fishery Regulations* (August 2010);
- s) Where required by new legislation affecting Nunavut wildlife, continue implementing relevant aspects of that legislation (for instance, the *Species at Risk Act* (SARA) and the *Nunavut Wildlife Act*).
- Reviewed proposed regional bird conservation strategy, and met with representative of Canadian Wildlife Service (August 5) to discuss concerns;
 - Actively involved throughout the year in the process of reviewing COSEWIC species status assessments (Atlantic halibut and northern bottlenose whale) and other relevant documents (i.e. Designatable Units for Caribou);
 - The NWMB made decisions as per S 5.3.17 of the NLCA for Eastern High Arctic Baffin Bay beluga, Cumberland Sound beluga, polar bear, and horned grebe (western population).

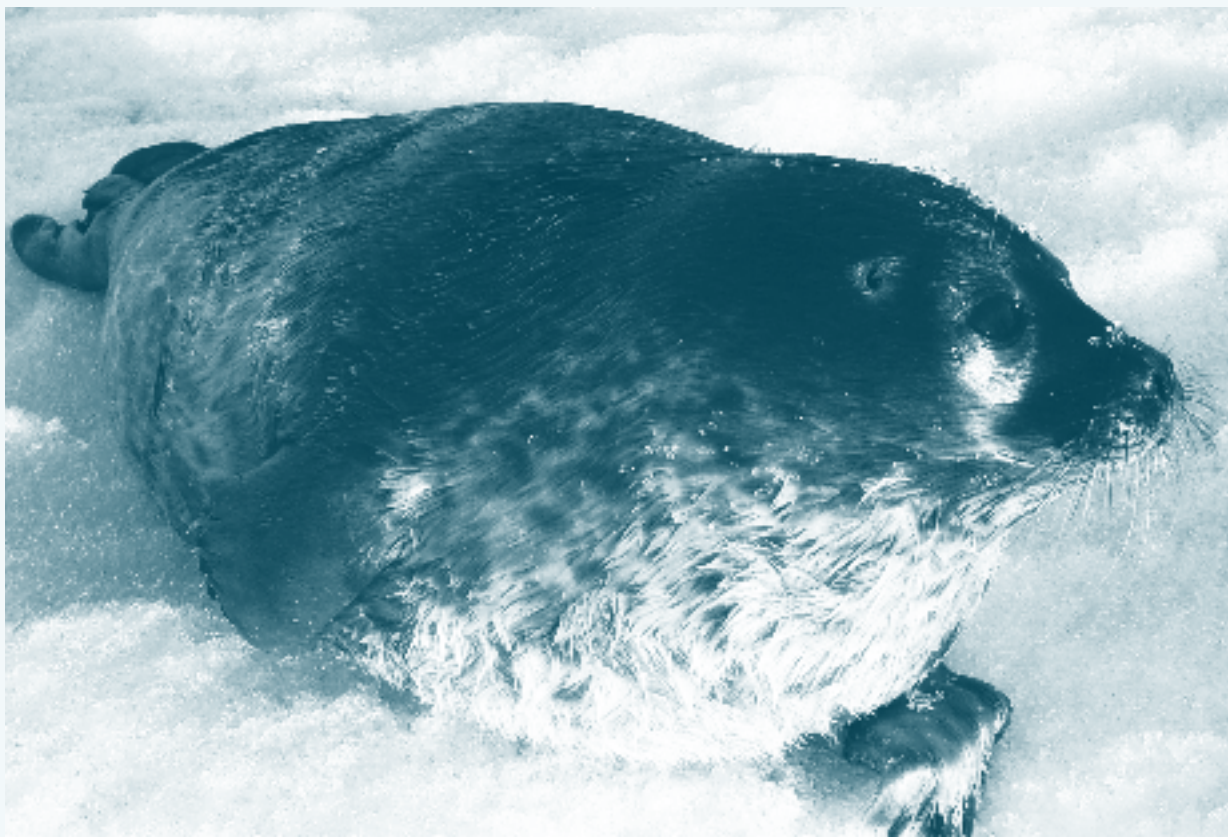

NOTES TO THE FINANCIAL STATEMENTS

1. NATURE OF THE ORGANIZATION

The Nunavut Wildlife Management Board (NWMB) is an institution of public government established pursuant to *An Agreement Between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in right of Canada*, also known as the *Nunavut Land Claims Agreement*. The NWMB is the main instrument of wildlife management and the main regulator of access to wildlife in the Nunavut Settlement Area (NSA). In addition, the NWMB identifies research requirements, funds research and carries out research in order to help maintain an effective system of wildlife management in the NSA. The Board also exercises an extensive advisory authority in the marine environment adjacent to the NSA.

The Board is exempt from income taxes under Sec. 149(1)(l) of the *Income Tax Act*.

2. SIGNIFICANT ACCOUNTING POLICIES

The accounting policies followed by the Board are in accordance with Canadian generally accepted accounting principles and include the following significant accounting policies:

(a) Use of Estimates

The preparation of the financial statements of the Board requires management to make estimates and assumptions based on information available as of the date of the financial statements. Therefore, actual results could differ from those estimates.

(b) Revenue Recognition

The deferral method of revenue recognition is followed. Revenue is recognized in the year in which the related expenses are incurred.

(c) Financial Instruments

The Board's financial instruments consist of cash, accounts receivable and accounts payable and accrued liabilities.

Financial instruments are reported at their fair values on the statement of financial position. The fair values are the same as the carrying values due to their short-term nature.

It is management's opinion that the Board is not exposed to significant interest, currency or credit risks arising from these financial instruments unless otherwise noted.

(d) Equipment

Equipment is recorded at cost. Depreciation is provided annually at rates calculated to amortize the assets over their estimated useful lives as follows:

Computer Hardware	30% declining balance
Computer Software	100% declining balance
Translating Equipment	20% declining balance
Office Equipment	20% declining balance
Automotive Equipment	30% declining balance
Furniture and Fixtures	20% declining balance
Leasehold Improvements	Straight-line over the term of the lease

One-half of annual amortization is recorded in the year of acquisition.

4. RELATED PARTY TRANSACTIONS

The NWMB pays for all overhead expenses pertaining to the operations of The Nunavut Wildlife Research Trust, a related party whose Trustees are also board members of the NWMB. There are no inter-organizational charges made for these services and their magnitude has not been established.

5. COMMITMENTS

The Board is committed to minimum annual lease payments under the terms of a lease agreement for its office premises as follows:

The agreement expires June 30, 2013. Payments are to be adjusted each year for inflation as measured by the Consumer Price Index. After 2010, the payments were adjusted to reflect the fair market rental value of the premises.

6. OPERATING CONTRIBUTION CARRY FORWARD

The Government of Canada, through the Department of Indian and Northern Affairs Canada, budgets funds allocated for the use of the NWMB for periods of 10 years during which all allocated funds must be spent or they may be retained by the Government. The current period expires in June, 2013. As at March 31, 2011 amounts totalling \$2,872,133 have been approved for carry forward to be used in addition to regular yearly funding for approved programs any time up to June, 2013.

NOTES TO THE FINANCIAL STATEMENTS

1. PURPOSE AND NATURE OF THE ORGANIZATION

In 1994, pursuant to *A Contract Relating to the Implementation of the Nunavut Final Agreement*, the Government of Canada provided the Nunavut Wildlife Management Board (NWMB) with a single payment of eleven million dollars for the establishment of a Wildlife Research Fund. Its intended purpose was to provide funding for territorial and federal government departments to carry out wildlife research approved by the NWMB.

Upon that basis, the NWMB established the Nunavut Wildlife Research Trust, which was designated a Registered Charity in 1996. Its Trustees are the members of the NWMB. Since 1997, the Trust has provided an annual funding allocation, exclusively available to government departments. That allocation is administered by the NWMB, in order to address wildlife research priorities as identified by the NWMB.

2. SIGNIFICANT ACCOUNTING POLICIES

The accounting policies followed by the Trust are in accordance with Canadian generally accepted accounting principles and include the following significant accounting policies:

(a) Use of Estimates

The preparation of the financial statements of the Trust requires management to make estimates and assumptions based on information available as of the date of the financial statements. Therefore, actual results could differ from those estimates.

(b) Fund Accounting

The Nunavut Wildlife Research Trust follows the restricted fund method of accounting for contributions.

(c) Financial Instruments

The Trust's financial instruments consist of cash, marketable securities, accounts receivable and accounts payable and accrued liabilities.

Cash, accounts receivable and accounts payable and accrued liabilities are reported at their fair values on the statement of financial position. The fair values are the same as the carrying values due to their short-term nature.

Marketable securities are reported at their fair values on the statement of financial position at year-end quoted market prices.

The Trust is exposed to market risk with respect to its marketable securities. Market risk is the risk of a financial loss resulting from adverse changes in underlying interest rates, foreign exchange rates, and equity prices.

3. MARKETABLE SECURITIES

The investment in marketable securities is used to fund research. The cost of these securities at March 31, 2011 is \$19,475,050 (2010 - \$19,372,482).

4. RISK MANAGEMENT

The Trust manages its market risk through an independent investment manager with oversight from the Trustees.

5. RELATED PARTY TRANSACTIONS

The Trust receives administrative services at no charge from the NWMB. The amount of these services has not been quantified.

6. INCOME TAX STATUS

The Trust is exempt from income taxes under Sec. 149(1)(f) of the Income Tax Act.
